Purpose of Appraisal

This appraisal is conducted to determine the Actual Cash Value of the subject vehicle as of the date of loss, specifically to address and dispute the valuation provided by State Farm. The appraisal presents a well-supported, documented value that reflects the true worth of the vehicle based on current market conditions, comparable sales, and the specific characteristics, options, and condition of the vehicle — most notably its purchased Full Self-Driving capability, which the carrier's comparables did not carry.

Intended Use

The intended use of this appraisal report is to serve as an authoritative document in support of the owner's dispute with State Farm regarding the valuation provided. This report may be used to negotiate a fair settlement and, where the policy's appraisal clause is invoked, to support the independent-appraiser process that resolves valuation disputes between the insured and the insurer. It may also be relied upon in mediation.

Intended User

The intended user of this appraisal report is the vehicle owner, who commissioned the analysis to address the carrier's valuation. The report is also intended for State Farm and its representatives, who may review it as part of the dispute-resolution process, and — if the appraisal clause is invoked — an independent appraiser or umpire selected to resolve the valuation dispute.

Scope of Work

Introduction

This Scope of Work outlines the methodology and procedures followed in conducting this vehicle appraisal in a manner consistent with the Uniform Standards of Professional Appraisal Practice (USPAP).

Identification of Subject Vehicle

- Adjust comparable vehicle values to account for differences in mileage, condition, options, and other relevant factors.
- Reconcile the adjusted comparable values to establish a market-derived value for the subject vehicle.

The adjusted comparable values support an opinion of value of \$29,155, materially above the carrier's initial offer of \$17,262. The dominant driver is the purchased Full Self-Driving option (\$8,000 factory price), absent from the carrier's comparables.

Market Analysis

The subject market was analyzed using current, like-for-like 2019 Tesla Model 3 rear-wheel-drive listings from official dealer inventory across multiple regions. Advertised prices for the comparable set ranged from \$18,500 to \$24,199, with an average of \$21,522 and a median of \$22,795 before adjustment for the subject's specific options and condition.

Two market realities drive the subject above the raw comparable average: (1) the subject carries **purchased Full Self-Driving**, an \$8,000 factory option not present on the comparable set, which the market rewards on resale; and (2) the subject's mileage (64,535) is at or below the comparable set, supporting a value in the upper portion of the adjusted range. Reconciled against these factors, the market supports an opinion of value of **\$29,155**.

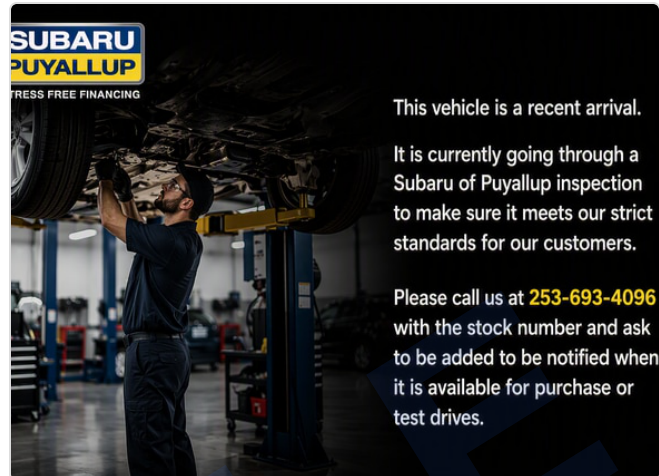

The comparable-sales approach was given primary weight. Four current, like-for-like 2019 Tesla Model 3 rear-wheel-drive comparables were drawn from official dealer inventory and adjusted for differences in mileage, autonomy hardware/software, interior grade, and appearance protection.

After adjustment, the indicated values cluster in support of the opinion below. The single most material factor is the subject's **purchased Full Self-Driving capability** — an \$8,000 factory option that transfers with the vehicle and was not present on the carrier's comparables — together with the subject's below-average mileage and documented condition.
